### **State of Utah Non-Resident Concealed Pistol License Classes (Legal Carry in 30+ States)**

**Class Date: January 29th 2012**

**Where: Timbers Restaurant, Toledo, Oregon**

**Session Length: Approximately five hours**

**Fee: \$100 (cash or check only) (This does not include the application fee to Utah for permit.)**

**Seating: Limited to 25 attendees per class session. Classes fill FAST!**

Utah's Weapons Laws and Reciprocity allow residents and non-residents holding CURRENT Concealed Pistol Licenses (CPL) to carry in 30+ states, providing the CPO holder adheres to that state's laws as pertaining to possession and carrying a handgun.

Utah Law requires only UTAH STATE provided/approved training materials and a copy of the Minimum Training Requirements be presented and training received in person from a Utah Certified Instructor in order to make application for a Utah CPL.

REGISTRATION DEADLINE: The Friday before class, 5:00 pm.
