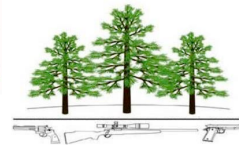

RIFLE RANGE CLOSURE

The rifle range will be closed for an extended period beginning **Sunday, July 22nd and continuing through Saturday, August 4th.** The closure will be to demolish and replace the rifle range shooting shelter roof. The only noted exception is for a previously scheduled law enforcement training date. No other shooting will be allowed on the rifle range during this period, whether or not work is actively being done. This is to insure that there are no injuries in the construction zone. The pistol range will remain open during this time for your use (PISTOLS ONLY on the pistol range, no shotguns or rifles) and no law enforcement or private training will be scheduled for that range during this period.
